5. Trish Pettigrew moved, and Ben Wootten seconded, to enter into an executive session with Fred Cole, Principal, for the purpose of contract review with Mark Hurvitt and the board per 1 M.R.S.A. 405 (6)(D)

- 9. Ben Wootten moved, and Prudy Heilner seconded, to eliminate the warrant article authorizing the superintending school committee to make a contract with the Trustees of George Stevens Academy for tuition of a majority of the secondary students.
